## **POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 25 AUGUST 2014**

The Board is pleased to announce that all the resolutions proposed at the AGM were duly passed by the shareholders by way of poll at the AGM held on 25 August 2014.

Reference is made to the circular (the “Circular”) of China Dynamics (Holdings) Limited (the “Company”) dated 24 July 2014. Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as those defined in the Circular.

### **POLL RESULTS OF THE AGM**

The Board is pleased to announce that all the resolutions proposed at the annual general meeting of the Company (“AGM”) were duly passed by the shareholders by way of poll at the AGM held on 25 August 2014.

As at the date of the AGM, the number of issued shares of the Company was 2,871,746,800 shares, which was the total number of shares entitling the holders to attend and vote for or against each of the resolutions proposed at the AGM. There was no share entitling the holders to attend and abstain from voting in favour of these resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and no holder of the Company was required to abstain from voting at the AGM under the Listing Rules. There were no restrictions on the shareholders casting votes on any of the proposed resolutions at the AGM.

Tricor Tengis Limited, the Company’s branch share registrar in Hong Kong, was appointed as the scrutineer for the vote-taking at the AGM.
